Menu: Only the menu items listed on your application may be sold and only at the prices listed on your application, unless approved in advance by the Vendor Director.

Signage: You are responsible for providing your own booth, equipment and signs. All signs must look professional. No signs bearing the name of companies other than the official Festival sponsors or your business as stated in the application are allowed. _____ (initial here).

Fee: There is an additional \$50.00 reporting, cleaning fee and inspection. This is non-refundable.

Sales Tax: You are responsible for charging and reporting applicable state sales tax.

Hours of Operation: Friday 5:00 p.m. to 11:00 p.m. You must be set up & ready to serve before 4:30 p.m. and must be open during the above hours unless prearranged with Vendor Director.

Hours of Set-Up: 1:00pm – 4:00pm **Tear Down:** 11:00pm

Certificate of Insurance: For the festival you must provide a certificate of insurance for one million dollars (\$1,000,000) naming Kla Ha Ya Days Inc., Snohomish County & Kandace Harvey dba Harvey Airfield as additional insured. _____ (initial here). Although limited security is provided, YOUR BOOTH AND CONTENTS REMAIN YOUR RESPONSIBILITY. Neither KLA Ha Ya Days Festival, Kandace Harvey d.b.a. Harvey Airfield nor Snohomish County assumes responsibility for injury to persons, or loss or damage to any property of the vendors, including theft.

Licenses: You are required to obtain a food permit from Snohomish Health Department. You will also be inspected by Dept. of Labor & Industries.

Location: I understand that I will be located in the FOOD COURT at Harvey Airfield.

Restrictions: No alcoholic beverages, loud music, televisions or hawking are allowed at the festival. The festival reserves the right to restrict any activities determined by the festival staff to interfere with public access and /or Festival programming.

In signing this agreement, you agree to comply with all Festival, state and local regulations, Fire, Health & Safety rules and guidelines and to save and hold harmless Kla Ha Ya Days Festival, Kandace Harvey dba Harvey Airfield and Snohomish County, their employees, officers, sponsors and agents from any loss or damage to any persons or property caused by the applicant's operation in connection with Kla Ha Ya Days, and further agree to defend said Associations and County for any claims for such damage.
