## **CERTIFICATE OF INSURANCE**

**A certificate of insurance evidencing Liability Insurance will be required for animal, float or motorized units.**

**COMMERCIAL ENTRY** The display of any business name and/or logo is considered to be a commercial entry and required to submit entry fee.

**DECORATIONS** All entries must be decorated in an acceptable and festive manner.

**RULES & REGULATIONS** Due to safety concerns for spectators and parade participants as well as the smooth and orderly flow of the parade the following rules and procedures must be followed:

- Firearm replicas are not to be used by parade participants at any time, stationary cannon's are allowed. \_\_\_\_\_ (Initials)
- Any item to be handed out to parade crowds must be approved in advance by the Organizing Committee. \_\_\_\_\_(Initials)
- No items of any kind may be thrown from a vehicle, float or trailer. All distributed items must be delivered to the side of the road by people on foot. \_\_\_\_\_(Initials)
- Items that are potentially dangerous, such as silly string, squirt guns may not be used at anytime. \_\_\_\_\_(Initials)
- Combining of units is not allowed without the prior consent of the parade organizer. \_\_\_\_\_(Initials)
- All Units must maintain a forward motion at all times \_\_\_\_\_(Initials)
- Equine Units are required to have a clean-up crew following the unit \_\_\_\_\_(initials)
